# MUNICIPAL ELECTIONS: SATURDAY, OCT 20

We have had questions re: which candidates support housing. We met with several in Saanich and Victoria.

Candidates that are most supportive are Fred Haynes (Mayor), Rishi Sharma, Shawn Newby. We also met with Ned Taylor and Rebecca Mersereau and both expressed an interest in working with industry to achieve housing affordability through density, rezoning etc. In addition, Karen Harper strongly opposed the EDPA – a bylaw that was very obstructive and costly. Candidates that must accept responsibility for the challenging development/permit processes in Saanich are long-term councilors Judy Brownoff (EDPA supporter) and Susan Bryce. As well, Richard Atwell (Mayor) voted against several new recommendations by Saanich staff to improve development timelines.

Most supportive candidates are Mike Geoghegan (Mayor), Andrew Reeve, Grace Lore, Anna King. The worst voting records re: housing are Ben Isitt, Pam Madoff and Geoff Young. They talk a lot about housing affordability but have voted against rentals and townhomes suitable for families. Beware the Together Victoria slate of Collins, Potts and Dubow which could form a voting block with Isitt, also a member of Together Victoria.

#### Colwood

Rob Martin (Mayor) in Colwood is the most supportive for housing development. Colwood has presented unreasonable challenges and costs to new developments and their new OCP, supported by Carol Hamilton (Mayor) and Cynthia Day will add more costs.

### Langford

Of course support for Langford's incumbents is a no-brainer with Stew Young's (Mayor) housing leadership building almost 50% of the new housing in the CRD.

You don't have to vote for an entire council, but it is important to vote for those that represent solutions to housing affordability. Here is VRBA President Todd Halaburda's column appearing in the Times Colonist next Wednesday, prior to the election:

#### ONE VOTE CAN MAKE THE DIFFERENCE

Municipal Elections are Saturday, Oct 20 and voters have two responsibilities - become familiar with the candidates and vote.

Some voters may feel overwhelmed learning the views of a dozen or more mayor and council candidates.

But even voting for a single candidate representing your concerns can make a big difference in how our communities develop.

Your candidate(s) should understand the market forces impacting housing supply and affordability.

They should realize provincial and municipal land use regulations such as zoning and EDPA's limit affordable land, resulting in our housing shortage and rising costs.

Federal, provincial and municipal building code requirements such as Step Code, permit fees, taxes and amenities represent over a quarter million dollars added to the cost of new homes in Greater Victoria.

These regulations, taxes and fees alone cost more than the average home on Canada's East Coast.

On the other hand, Langford represents the Gold Standard for affordable, energy efficient market housing. They have a strong track record and presently build almost 50% of new housing in the CRD.

But they can't do it alone. The other 12 municipalities must make housing a priority to ensure affordable homes are available to accommodate young families.

Obstructive permit processes, uncertainty and high costs are all-too-common in our region, especially in Saanich and Victoria.

Candidates must do more than claim to support housing affordability, especially long-term incumbents. When there are housing affordability problems in their municipalities, they must shoulder the responsibility.

To achieve an affordable place to call home, take the time to review candidates demonstrating real knowledge and

appreciation of housing supply issues.

Einstein said it best - "We cannot solve our problems with the same thinking we used when we created them."

One vote can make the difference.
